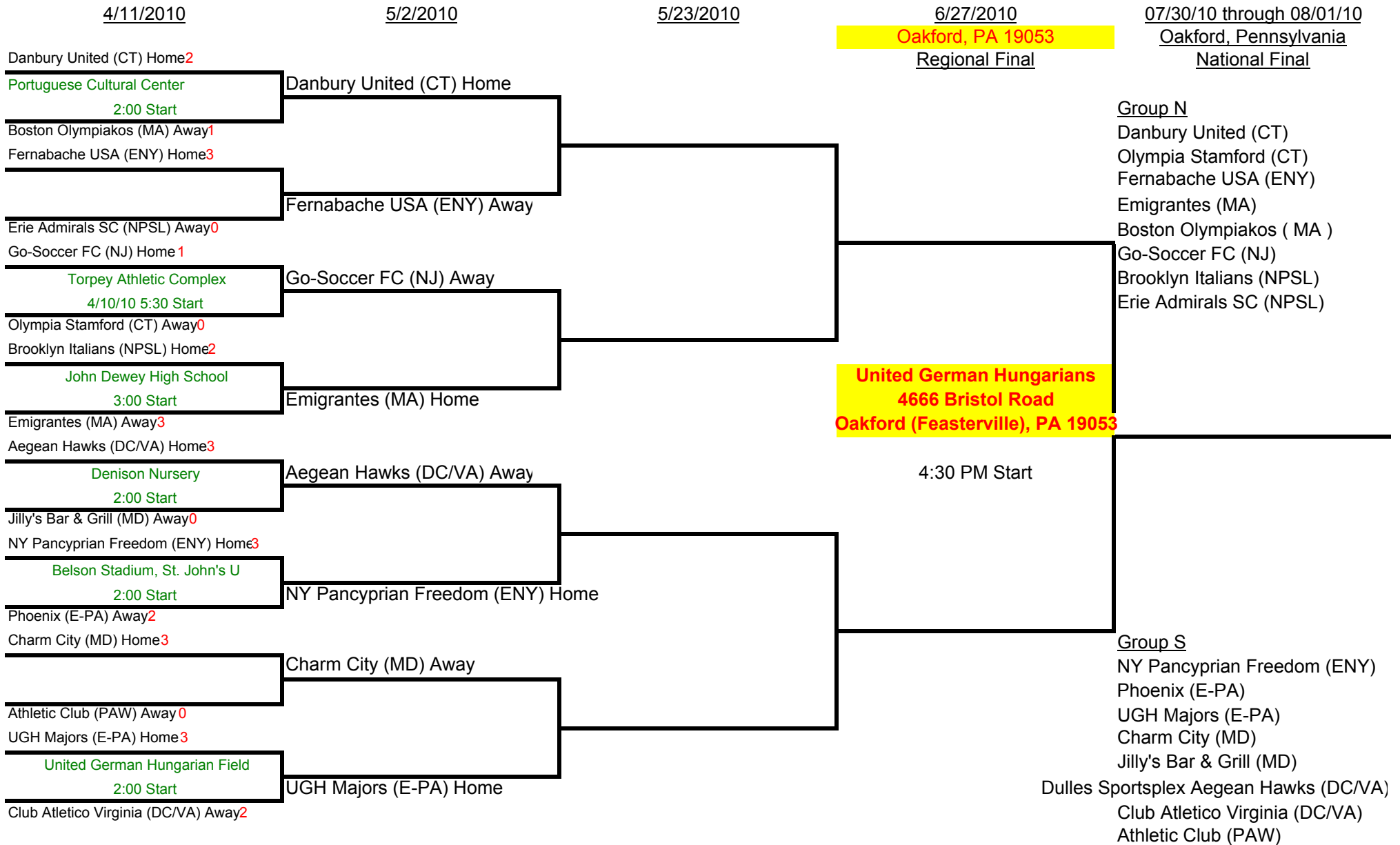

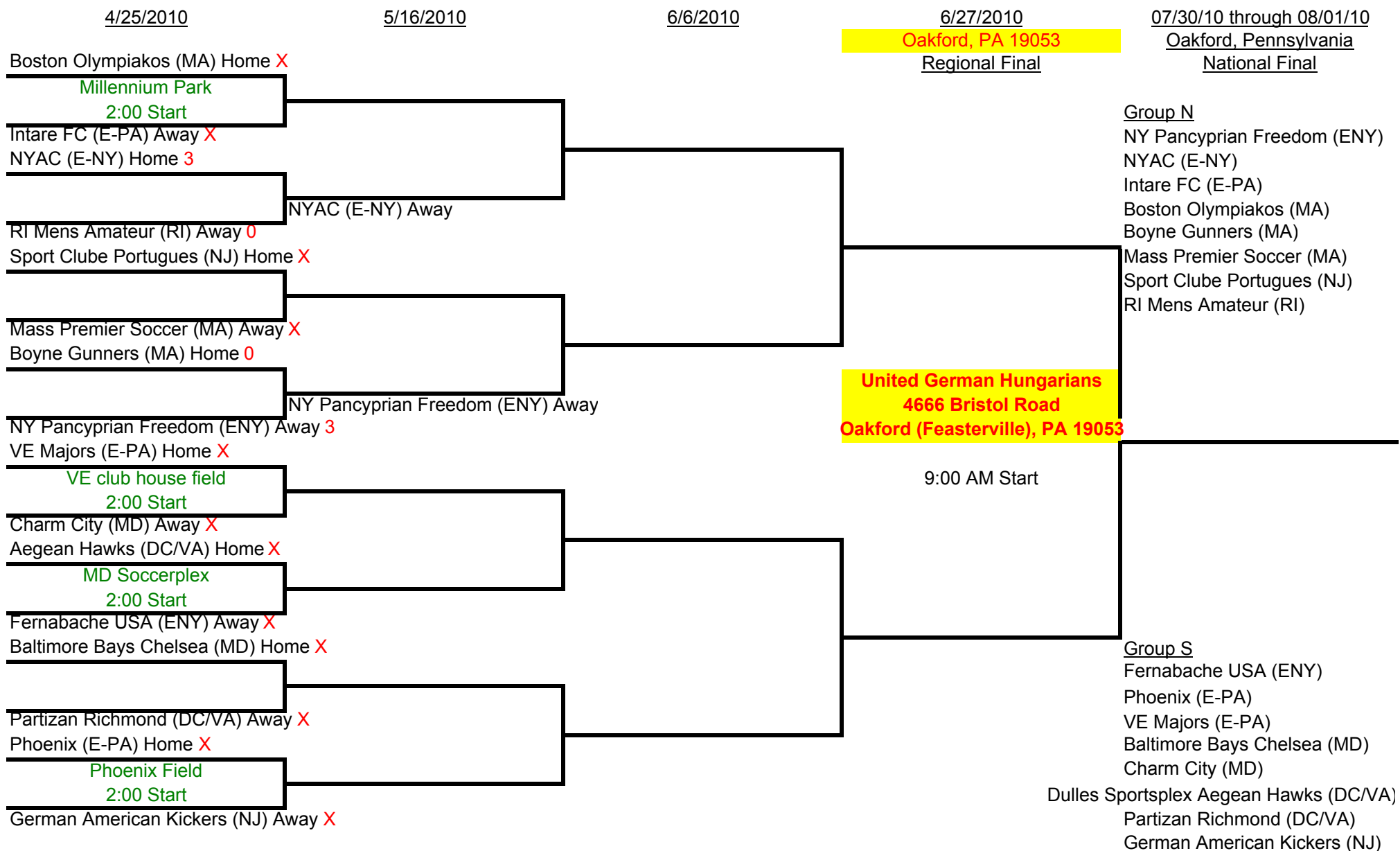

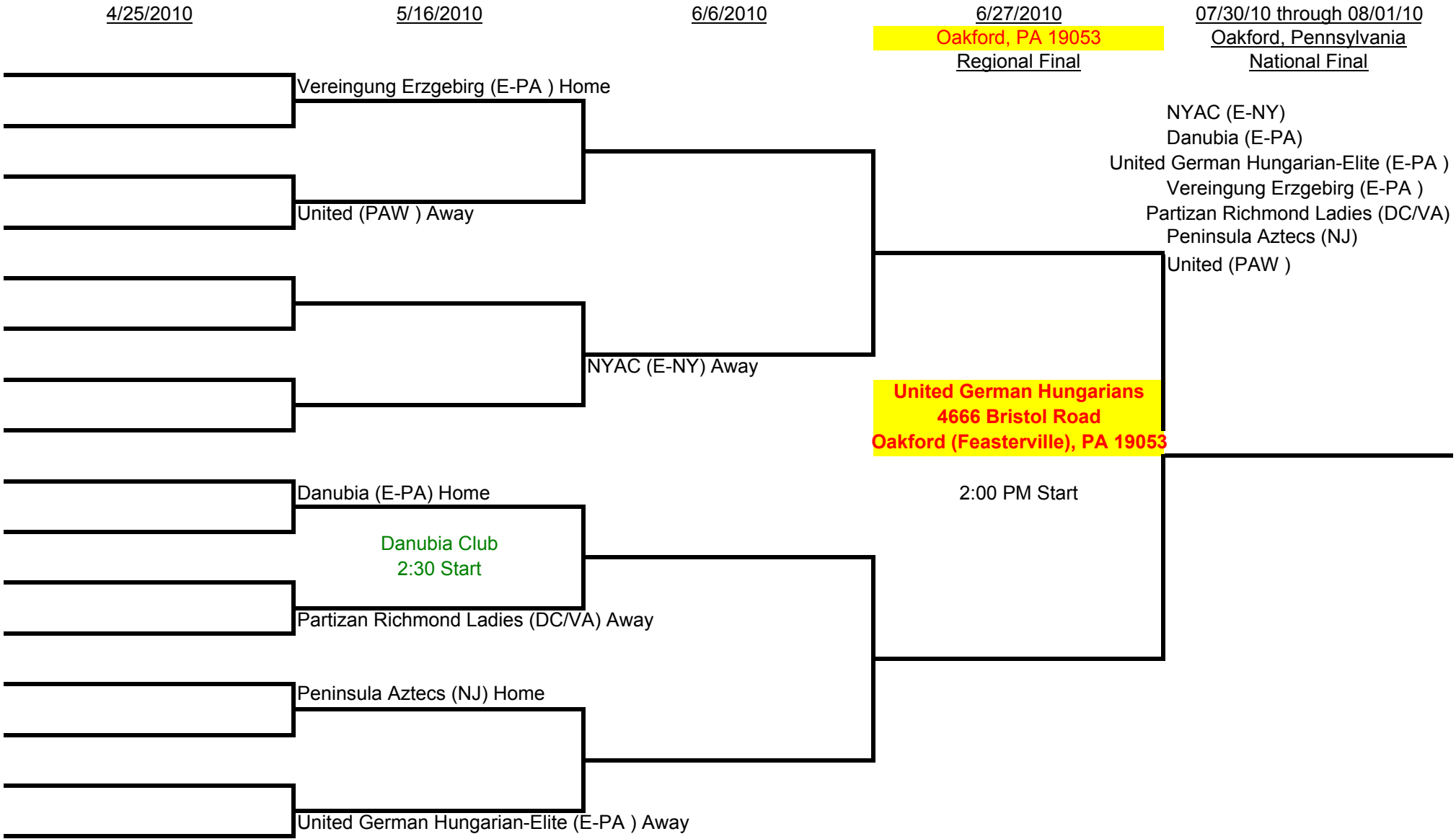
Men's US Over 30 Cup
